We can't provide any codes until we receive by fax a copy of your driver's license, as well a copy of your business license, locksmith license, or sales permit. Once we have all your paperwork, your code requests for key codes, security PIN codes, radio security codes, immobilizer reset information, special tool requirements and information, etc. can be processed from that point on. The normal time needed to process a code request is 15 to 30 minutes for non-GM/non-Ford related codes available & 30 minutes for GM/Ford-codes available. Exceptions may occur and longer times may be needed depending on the location, type, or age of the vehicle as well as the information requested.

A Street Keys / KeylessRide / Secured Mobility representative will contact you by phone, email, or fax when the requested code is available.

The codes we'll provide are based on the VIN and are compatible with equipment when the vehicle was built. Street Keys / KeylessRide / Secured Mobility are not responsible if the codes are no longer compatible with any locks or engine control computers that have been installed after the initial production date.
